ODOMETER DISCLOSURE

Lessee must certify to the best of the Lessee's knowledge that the odometer readings on the vehicle accurately reflect the actual miles for each vehicle unless otherwise noted and properly documented.

Mileage

Try to keep your mileage within the limits set in your lease agreement. Check your lease agreement to confirm the annual maximum number of miles you may drive during the lease term. Excess mileage charges will be assessed if you exceed the annual maximum number of miles as stated in your contract.

Turn-In Fee

If Lessee does not purchase or replaces the lease with a new lease or loan, a turn-in fee will be charged per vehicle. The turn-in fee is waived if Lessee replaces vehicle with new lease or loan on a new Isuzu truck with Isuzu Finance.

GENERAL

Each vehicle will have a title free and clear of all liens and encumbrances at the time of its return. All replacement parts bought throughout the time of the lease must meet original equipment manufacturer's specifications. Each vehicle must be deidentified prior to return. All stickers, nameplates, decals, etc., must be removed. All damage to the finish resulting from the activity must be repaired. Any vehicle that has been wrecked must be declared at the onset of the return process and any wreck damage is subject to reappraisal and/or re-inspection. Cost differential as of result of damage repair is the responsibility of the Lessee.

At the conclusion of the lease, the vehicle must pass DOT inspection, meet end of lease terms and be able to go into service without repair. Each vehicle must be in roadworthy condition and all original equipment or replacement equipment of similar value made by the same manufacturer will be intact and in good working order and free of any mechanical problems to any of its parts and accessories. Permanently installed attachments must remain with the vehicle unless a written exemption is executed by each of the Lessor and Lessee. If attachments are removed the vehicle must be returned to its original condition.

CHECKLIST

- Review your Lease Agreement.
- Check for excess mileage, wear & use and complete needed repairs to avoid charges.
- Get Truck inspected.
- Contact your Isuzu dealer to review your end of lease options.
- Remove any personal items from the truck.

The Isuzu Finance Lease Return Guidelines are designed to help you make the right decisions during your lease.

Making sure you are familiar with the proper care and maintenance will help you not only take care of your truck, but also avoid charges for excess wear and tear at the end of your lease.

PREVENTATIVE MAINTENANCE

Follow the manufacturer's guidelines for proper maintenance. This guide can be found in your owner's manual.

Exterior

Keep exterior dings, chips, scratches, corrosion, etc. to a minimum. To stay within normal wear and tear, try to keep total cab and body damage to less than \$500.00.

Interior

Keep your seat fabric, carpet, floor mats, headliner, door liner, and cargo areas free of burns, cuts, tears and stains. Stains must be easily removable.

Glass, Lenses & Mirrors

Try and keep glass free of damage. Make sure that headlights, brake lights, turn signals, and mirrors are kept in proper operating condition and free of damage.

Missing and Broken Parts

Missing and broken parts are subject to charges at the time the truck is returned. All replacement parts purchased throughout the term of the lease must meet original manufacturer's equipment specifications.

Electrical Maintenance

All power equipment – lights, audio equipment, security systems and other electrical components must be maintained in good working condition.

Alterations

Please do not perform any mechanical modifications to your truck such as changes in the suspension, engine adaptions, post-delivery customizations, fuel system adaptions, wheelbase alterations, etc. All body alterations such as vehicle coloring, lettering or graphics, tinted or engraved glass, etc. must be restored to original condition prior to returning the truck.

END OF LEASE INSPECTION

You will receive two letters from us. One at sent 180 days and one sent 90 days prior to maturity where you are to advise us of your lease-end intensions. If you intend to return the truck you are responsible to schedule a lease-end inspection by a third party inspection company provided to you by us **PRIOR** to maturity date. You are required to bring the truck to return conditions. You are responsible for any charges from excess mileage or items that exceed normal wear and tear and will be invoiced listing the inspection findings and any subsequent charges. The cost of the original inspection **PRIOR** to maturity will be paid by Isuzu Finance. The cost of any inspections after the maturity date will be the Lessee's responsibility. To avoid charges you can have the truck repaired yourself through an authorized Isuzu dealer. The following is a list of items that will be examined by the inspector, and what is expected in terms of condition:

Engine

Must be mechanically and operationally sound. It must be within the manufacturer's specifications with regard to oil pressure, coolant temperature and pressure, as well as fuel and rail pressures. The engine must operate at minimum 80% of the original manufacturer's rated horsepower after allowing for driveline losses. Engine must have no oil leaks or coolant leaks and must be free of internal contamination. Electronic engines must retain mileage information. Battery, starter, alternator and other ignition system components must be in sound condition and capable of starting and charging the system under the chassis's own power. Batteries must be intact with no dead cells. Air conditioning compressor must be operational. System must be free from defect and blow cold air.

Drivetrain

The clutch, transmission, and both front and rear axles must be roadworthy and free from defects, with no visible bends, cracks, or leaks. Clutch must be in adjustment or must be replaced if it cannot be adjusted to within the acceptable tolerances. The driveline must be free of noise and vibration, and excessive free-play in u-joints. Transmission, cooler assembly, and rear axle must have no fluid leaks.

Brakes

Brake linings are to be no less than fifty percent (50%) of original specifications. All drums and rotors must be within useable tolerances.

Tires

Tires must be originals (no caps). Tire tread depth must be no less than 50% of new at the lowest point with no irregular wear. Casings must be sound without cuts, bulges or gouges. Wheels must be free of cracks with no broken wheel studs.

Frame

Frame rails, cross members, cab mounts/supports, suspension hangers and other structural systems must be free of cracks, improper welds and other defects. All pins and bushing must be free of play or within manufacturer's published tolerances. Frames that have been improperly repaired, welded or otherwise altered are not acceptable. Vehicle must track straight during road test.

Cab/Body

Cab and body damage must not exceed \$500.00, including bumper, grill, fuel tanks, fairings, dents and rust damage, etc. All attached body equipment and hydraulic components must be in good working order and free of fluid leaks. All radio and power accessories must be intact and operational. Upholstery, headliner, and door liners must have no tears, burns, stains, or open seams. All dash components must be in place and in operating condition. Dash panels and interior trim pieces must not be missing and must be free from holes, cracks and breaks. There must be no broken or cracked glass and no "bulls-eyes" in the glass. All power equipment, lights, audio equipment, security systems and other electrical components must be maintained in good working condition.

Lease inspection criteria is based on the industry accepted standard of "trade terms and conditions" as published by the Used Truck Association.
